

ORDINANCE NO. 4-2007

AN ORDINANCE REGULATING THE STOPPING, STANDING OR PARKING OF VEHICLES IN CERTAIN AREAS OF THE VILLAGE OF ANSONIA, OHIO, ESTABLISHING THE PENALTIES FOR THE VIOLATION OF THE PROVISIONS OF THIS ORDINANCE AND REPEALING INCONSISTENT LEGISLATION

BE IT ORDAINED by the Council of the Village of Ansonia, Ohio, that:

SECTION ONE

Parking within the Village shall be regulated as follows:

- a. The following areas shall be designated as “No Parking”:
 1. The north side of West Canal Street (State Route 47) from Pearl Street west to the west corporation line.
 2. The south side of West Canal Street (State Route 47) from Olive Street west to the west corporation line.
 3. The south side of Carriage Way Drive from the west side of Baughman Street west to the point where Carriage Way Drive turns to the south.
- b. The west side of Tiger Way Drive from East Cross Street to a point 160 feet north of the intersection of East Canal Street shall be designated as “NO PARKING School Days from 7 am to 4 pm”.
- c. The west side of Tiger Way Drive from East Canal Street to a point 160 feet north of said intersection shall be designated as “No Parking Here to Corner”.
- d. The first parking space south of the intersection of North Main Street (State Route 118) and West Canal Street on the west side of Main Street shall be designated as “Ten (10) Minute Parking Only”.
- e. The north side of West Canal Street 94 feet west of North Main Street for a distance of 32 feet shall be designated as “No Parking – Police Cars Only”.
- f. The following areas shall be designated as “Handicapped Parking Only”:
 1. The first parking space west of South Main and West Weller Streets on the South side of West Weller Street.
 2. The first parking space east of the north-south alley parallel to and between North Main and North Pearl Street on the north side of West Cross Street.
 3. The west side of North Main Street (State Route 118) from a point 120 feet south of West Canal Street for a distance of 22 feet.

- g. The west side of North Main Street (State Route 118) from a point 78 feet south of West Canal Street for a distance of 10 feet shall be designated as “Motorcycle Parking Only”.

SECTION TWO

Whoever violates Section One of this Ordinance shall be guilty of a minor misdemeanor.

SECTION THREE

The Village Administrator is hereby authorized to purchase and erect signs as necessary to inform the public of such regulations.

SECTION FOUR

Ordinance No. 14-1989, Ordinance No. 16-2001, Ordinance 9-2004 and any and all inconsistent legislation is hereby repealed.

SECTION FIVE

This Ordinance shall take effect and be in full force from and after the earliest period allowed by law.
