

RESOLUTION NO. 5-2008

**A RESOLUTION FOR REPLACEMENT OF THE TAX LEVY FOR
CURRENT EXPENSES FOR THE VILLAGE OF ANSONIA, OHIO**

BE IT RESOLVED by the council of the Village of Ansonia, Darke County, Ohio, that:

SECTION ONE

The amount of taxes that may be raised by the levy of taxes at the maximum rate authorized by Ohio Revised Code Section 5705.02 and 5705.19 on the taxable property in the Village of Ansonia will be insufficient to provide an adequate amount for the necessary requirements of the Village of Ansonia, and that it is necessary for the purpose of providing additional funds for the current expenses of the Village of Ansonia, that taxes be levied on the taxable property in said Village for a period of five (5) years at a rate in excess of such maximum rate.

SECTION TWO

It is necessary to levy taxes for the years 2009, 2010, 2011, 2012, and 2013, at a rate not exceeding 2.6 mills for each dollar of valuation, which amounts to twenty six cents on each \$100.00 of valuation of taxable property within the Village of Ansonia, for replacement of a tax of 2.6 mills.

SECTION THREE

That the Clerk is directed to certify a copy of this Resolution to the Board of Elections of Darke County, Ohio, in order that said Board of Elections may cause notice of election on the question of levying said tax to be given as required by law, and to make the necessary arrangements for the submission of said question to the electors of the Village of Ansonia at the election to be held on the 4th day of November, 2008.

SECTION FOUR

This Resolution shall take effect from and after the earliest period allowed by law.
